I also agree that I will indemnify and hold harmless Releasees if any of my successors, agents, heirs, assignees, guardians, next of kin, spouse, or legal representatives asserts any claim, suit, action, or other form of liability against any Releasee in connection with any of the matters covered by the foregoing release.
